2. A PROTEST MUST BE LODGED WITH A REFEREE PRIOR OR DURING THE MATCH.
3. IN THE EVENT OF AN ALLEGED INELIGIBLE PLAYER – A PROTEST MAY BE LODGED AFTER THE FACT WITHIN 7 DAYS OF THE COMPLETED MATCH.
4. CLUBS ARE REQUIRED TO BRING THEIR OWN WITNESSES TO EITHER DEFEND OR PROSECUTE ANY ALLEGATION / CHARGE.
5. FAILURE TO WIN YOUR PROTEST/COMPLAINT WILL RESULT IN FORFEIT OF THE FEE.
