PLEASE NOTE:

1. A club intending to lodge a protest shall submit a written intention to protest on the prescribed form, signed by a club executive member, to the Association within four (4) days of the completion of the match, together with the protest fee of R700.00 and proof of payment. The proof of payment must reflect the Club Name, Team Protesting, Opposition and Date of Fixture. A protest not accompanied by the prescribed fee and proof of payment within the timeframe shall not be entertained (R&R 11.2).
2. Within two (2) days after the expiry of the four (4) day intention period, the protesting club must submit:
 - 2.1 Full written grounds of protest.
 - 2.2 Supporting statements, documents and evidence.
